a. The approved Preliminary Site Plan together with all proposed additions, changes or departures therefrom, if applicable.	
b. Submission of certification of completion of the following required improvements:	
Proposed public streets; Private roads; Curbs, shoulders, and guard rails;	
Water, sanitary sewers, drainage, and other roadbed utilities; Individual lot utility connections to a minimum of 10 feet beyond the curb line;	
On-tract drainage facilities; Off-tract improvements; Electric, telephone and other non-roadbed utilities, unless exceptions as permitted in 10-8.3k of this Article apply;	
All other improvements required by the Planning Board.	
c. Secondary Improvements. In addition to the above, prior to consideration by the Planning Board of a Final Plat of a major site plan for Final Approval, the applicant shall have installed or shall have filed Performance Guarantees, in accordance with Article 11 of this ordinance, for the ultimate installation of the following secondary improvements as required:
