Mayor & Borough Council Meeting Minutes January 22, 2018

Mayor Kevin Sooy called this meeting to order at 7:00 p.m. Present were Council Members Jeffrey J. DeLeo, Thomas O'Dea, Jr., Chris Schmidt, Michael Sullivan and Christine Zamarra. Also present were John Pidgeon, Borough Attorney, Ralph A. Maresca, Jr., Administrator/CMFO and Anthony Suriano, Acting Clerk. Michael dePoortere was absent.

Notice of this meeting was provided to the Bernardsville News, Courier News and the Star Ledger, filed with the Municipal Clerk and posted on the Municipal Bulletin Board on December 12, 2017.

PLEDGE OF ALLEGIANCE

PRESENTATIONS

Frank Mottola, Administrative Officer of the Planning Board and Zoning Board called the roll. Present for the Board of Adjustment were David Greenebaum, Ed English, Anthony Dello Russo, Jeff Sailliard, Diana Kramer, Paul Sedlak, and Ed McDowell. Absent were Russell Giglio, Thomas Carton, Rich Traynor, and Christopher Otteau. Present for the Planning Board were Karen Gardner, Jeff Horowitz, Dorothy Paluck, and Michael Sullivan. Absent were Robert Graham, Terry Thompson, Mary Kellogg, Bonnie Seller, and Hal Simoff.

Mr. Greenebaum, Board of Adjustment Chairperson, presented the Annual Report. There were no comments or questions from council. Mr. Dello Russo expressed that there is a good blend of talent on the board. Mr. Greenebaum mentioned observations/recommendations from the Board of Adjustment which include more vigorous zoning enforcement throughout the borough; requesting the Planning Board to address existing non-conforming use by conforming the language; architectural streetscape design standards consistency. Mr. O'Dea said he supports the streetscape design standards. Mr. DeLeo asked what the process would be. Mr. Pidgeon stated that the Planning Board should make a presentation to the council, an ordinance would be drafted and the masterplan would be amended. Mayor Sooy said that the process is in place. Mr. Mottola mentioned that the recommendations from the downtown revitalization survey are being reviewed with public input. Mr. Sedlak said step one is to get public input, have a strategy, and a vision plan. He said this is not a patchwork solution and there will be scheduled visual public sessions that will include businesses. Mr. O'Dea inquired as to the length of the project. Mr. Sedlak mentioned that the Planner will present a statement of work in February and then we will have a better a timeframe. The Board of Adjustment adjourned their meeting. The Planning Board did not have quorum.

APPROVAL OF MINUTES

Mr. Schmidt moved approval of minutes of the meeting held December 28, 2018 (Mr. Youngblood and Mr. Schmidt were absent), January 3, 2018 (Mr. Schmidt was absent) and January 8, 2018 (Mr. DeLeo was absent). Mr. Sullivan seconded the motion, which was approved with five yes votes.

Michael Storms, a Bernards Township resident, said he was intimidated when he recently saw police officers with large vests and no badge or name tag and asked not to let militarization of the police force exist. Mayor Sooy said police officers are permitted to wear outer garment vests and that does not constitute militarization of the police force.

Mr. Schmidt asked Patrolman Chertoff who was in attendance if the uniforms they wear all the time would have their names hidden. Patrolman Chertoff answered that their names are on the uniforms.

Mr. DeLeo moved that Ordinance #18-1758, AN ORDINANCE PROVIDING FOR IMPROVEMENT OF MINE MOUNT ROAD BY THE BOROUGH OF BERNARDSVILLE, COUNTY OF SOMERSET, NEW JERSEY, AND MAKING AN APPROPRIATION OF \$223,500 THEREFOR CONSTITUTING PROCEEDS OF A GRANT FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION, be introduced by title, passed on first reading, published according to law, and that a public hearing be scheduled for a meeting beginning at 7:00 p.m., February 12, 2018. Mr. Schmidt seconded the motion, which was approved with five yes votes.

Feral Cats at Borough Compost Site

Code Blue Activation Plan

Council consent was given to authorize the OEM Coordinator to sign off on acceptance of the Code Blue Activation Plan.

Reimbursement to Bonnie Sellers for SurveyMonkey

Council consent was given to reimburse Bonnie Sellers \$408 for the cost of signing up with SurveyMonkey to host the downtown revitalization survey.

Request from Community In Crisis for Temporary Sign Permit

Council consent was given to allow this request to have temporary signs at the Olcott Square triangle from January 25th to February 2nd.
