BOROUGH OF BERNARDSVILLE RESOLUTION 20-136

EXTENDING THE PROPERTY TAX DELINQUENCY GRACE PERIOD TO JUNE 1, 2020

WHEREAS, second quarter property taxes are due on May 1, 2020, with the grace period running through May 11, 2020; and

WHEREAS, due to the COVID-19 pandemic, property taxpayers throughout the Borough of Bernardsville and the State of New Jersey may be suffering from one or more financial hardships caused by or related to the pandemic; and

WHEREAS, on April 28, 2020, Governor Philip D. Murphy signed Executive Order 130, pursuant to and under the authority of his Declaration of a Public Health Emergency and State of Emergency, in which he declared that the strict enforcement of certain statutory provisions relating to property tax grace periods is detrimental to the public welfare; and

WHEREAS, under Executive Order 130, Governor Murphy authorized municipal governing bodies to adopt a resolution extending the property tax delinquency grace period from May 11, 2020, through a date no later than June 1, 2020, for the payment of second-quarter property taxes; and

WHEREAS, the governing body wishes to extend the grace period as authorized by Executive Order 130;

NOW THEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Bernardsville, in the County of Somerset, State of New Jersey, as follows:

- 1. It does hereby extend the delinquency grace period on the payment of second quarter of 2020 property taxes through and until June 1, 2020.
- 2. The Borough Clerk is hereby directed to notify the Director of the Division of Local Government Services in the Department of Community Affairs of this action taken by the Borough Council, as memorialized in this Resolution, not later than the third business day next following the adoption of this Resolution.
